NOTICE INVITING EXPRESSION OF INTEREST UNDER DDU-GKY.2.0 IN THE STATE OF NAGALAND

Nagaland State Rural Livelihoods Mission (NSRLM) invites EOI under Deen Dayal Upadhyaya Grameen Kaushalya Yojana 2.0 (DDU-GKY 2.0) for the state of Nagaland from the eligible Project Implementing Agencies (PIAs) having new Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD), Govt. of India for placement linked skill development training for rural poor youth in the financial year 2025-26. Interested PIAs having valid PRN, may apply in online portal of MoRD i.e. <https://kaushal.rural.gov.in> along with the non-refundable fees of ₹25,000/- (plus applicable 18% GST) for initial Screening through RTGS in favour of Project Appraisal Agency NIRDPR DDUGKY Savings Bank Account No. 62431332037, IFSC Code-SBIN0020965.

Applicable agencies will be intimated to deposit ₹1,25,000/- plus 18% GST for Qualitative Appraisal. Applicant should read the DDU-GKY 2.0 guidelines and procedures carefully before applying.

Under DDU-GKY 2.0 scheme, agencies are encouraged to train and place candidates according to the skill gap existing in different sectors preferably in the following Sectors like **Tourism & Hospitality, Beauty & Wellness, Aviation, Automotive, Constructions, Electronics, IT & ITES, Healthcare, Food Processing.**

1. Information while putting up proposals:
 - a. Interested Agencies may apply for short-term duration courses (minimum 576 Hrs-3 months up to 4.5 months courses duration respectively).
 - b. Preference will be given to those PIAs with proven record in placement and those PIAs with training centres in Nagaland.
 - c. Proposals from eligible PIAs covering Persons with disabilities (PWDs) candidates will be given preference.
 - d. Submission of proposals other than the above-mentioned Sectors will not be considered unless exceptional otherwise.

The proposals should be submitted on or before **10th June 2025**. Application received after aforesaid date shall not be entertained in this round of appraisal. Incomplete proposal in any respect shall be summarily rejected.

The application process is a complete online process hence there is no need to send the hard copy of documents. The entire process of application of proposals, screening & selection will be done strictly as per the guidelines and norms laid down by MoRD for the purpose.
