1. Introduction

Like many other countries, India is blessed with a demographic dividend and so is Karnataka. Government of Karnataka's current focus is on skills development and creating jobs. Karnataka is an example of a fine balance of modern industrial development, knowledge, skills and a responsive government and District skill missions for bottom-up approach in design and implementation of Skill Development programmes. With the launch of demand-driven PMKVY 3.0, SANKALP, Talent Acceleration Programmes (TAP), CMKKY scheme in the state, Karnataka has improved its focus on implementation of demand-driven skilling interventions.

Karnataka Skill Development Corporation (KSDC)

SDEL is the umbrella body for all skill development, entrepreneurship and livelihood initiatives of the Karnataka State. The Government has designated KSDC as nodal agency for conducting skill training programmes in the state.

Since its inception in 2016, the Karnataka Skill Mission under Department of Skill Development, Entrepreneurship and Livelihood (SDEL) has made significant progress in empowering youth with improved skills, knowledge, and employment opportunities to fuel the State's growth. In addition to futuristic job roles and industry-driven skilling.

a) Mission

1. Shall have an institutional mechanism and implementation framework that ensures an effective **CONVERGENCE**. The programmes and schemes of different line departments of the Government of Karnataka, Government of India, Industry sector, skill councils, civil society and bilateral/multilateral agencies and other organizations will be converged at the implementation level for achieving the policy goal and ensure the best services to the primary stakeholders.
2. Shall ensure **QUALITY** in the training curriculum and course materials to meet the standards of the employer agencies and market needs. Shall improve certification norms for augmenting employability and free movement of the workforce.
3. Shall encourage **INNOVATION** both in idea as well as in implementation process so that the ideas are translated to productive action
4. The institutional structure would operate in a mission mode having an eclectic mix of people from Government, Industry, Civil Society, Academia, Banking and Commerce Institutions

b) Nodal Agency for Skilling

The Government has decided to integrate various skill building programmes implemented by different departments to ensure the effectiveness of Skill Training activities. The vision of the Government was to bring in a centralized system of selecting and monitoring skill training courses and Institutions besides tracking the, trainees till they get employed. Hence the Government has declared the Karnataka Skill Development Corporation as a Nodal Agency for entire state in the year 2016. This ensured adopting common standard framework of programmes and fee structures, by which overlapping, or duplication of efforts and wastage of resources will be avoided. This declaration helps in creating synergy among different departments engaged skill development activities.

c) Objective

The objective of Karnataka Skill Development Corporation (KSDC) is to enhance the employability of youth by providing industry-relevant skill training, fostering entrepreneurship, supporting traditional and emerging job roles, and bridging the gap between education and employment opportunities.

2. Objective of endangered Traditional/Regional job roles training - EOI

In the Budget announcement for FY 2025-26 (CM Budget Para 255), provision has been made to provide short-term training along with necessary toolkits to 2000 candidates from across various districts of Karnataka in endangered Traditional/Regional job roles. The objective is to pass-on skills nearing extinction to the next generation, while also preserving and promoting GI-tagged and region-specific heritage crafts through structured skill development training and the creation of sustainable livelihood opportunities.

In this regard, KSDC invites Expressions of Interest (EOI) from eligible government institutions/private training providers with experience in imparting training in traditional crafts.

This program will focus on skilling and upskilling participants under NSQF-aligned job roles, while integrating traditional design elements and encouraging product diversification.

This training will result in revival and continuity of endangered skills within their cultural context, increased incomes and employment opportunities for artisans, enhanced visibility of India's regional heritage in domestic and global markets and strengthened identity and pride in traditional arts and crafts rather than mandatory wage placement, as per the job roles identified by the DSDO.

3. Scope of work

The scope of work to be undertaken by the Vocational Training Providers (VTPs) under KSDC for Traditional/Regional Job Roles skill training is as follows:

- Mobilize and select candidates from Traditional/Regional clusters through outreach and counselling.
- Provide comprehensive orientation to candidates about the project, scheme benefits, assessment, certification, and livelihood opportunities.
- Ensure a high-quality training environment with adequate infrastructure, tools, raw materials, and sector-specific equipment in accordance with NSQF norms, verified by the District Skill Committee and inspected as per standards.
- Select qualified trainers from among Traditional/Regional skilled workers/artisans who possess practical expertise in the identified endangered skills.
- Provide course curriculum, participant handbook, and facilitator handbook tailored for the selected job roles, with additional content on traditional designs, product diversification, entrepreneurship, and digital marketing.
- Ensure timely assessment and certification of candidates in coordination with KSDC and the relevant Sector Skill Council (SSC).
- Maintain biometric attendance of candidates and trainers, and ensure training centers are equipped with CCTV cameras as per NSQF norms.
- Adhere to prescribed procedures for allocation of targets, training delivery, assessment, certification, and post-training support, as per instructions issued periodically by KSDC and the Government of Karnataka.
- Officially register as a Vocational Training Provider (VTP) on the Kaushalkar portal (www.kaushalkar.com) under the CMKKY Scheme.
- Provide relevant toolkits to all successfully certified candidates to support post-training livelihood activities.
- Support artisans in strengthening Traditional/Regional skills and creating avenues for self-employment.

- Job roles identified for districts is given at Annexure – 1.

4. Eligibility Criteria:

1. The applicant must be a government organization/Institute or an organization registered in Karnataka as a Company/Partnership/NGO/SHG/Society/Trust/Vocational Training Provider working in the field of **Traditional/Regional skills/art forms** for a minimum of 3 years.
2. The applicant must have a minimum financial turnover per year of ₹25 lakh in each of the last three financial years (FY 2021-22, 2022-23, 2023-24).
3. The applicant should have proven experience in training, capacity building, or livelihood promotion of artisans, preferably in **endangered Traditional/Regional job roles** identified.
4. The applicant must have a functional training facility to accommodate a batch of 30 trainees.
5. Applicants shall demonstrate market linkage capacity with artisan collectives, government agencies (KHDC, KSHDC, KVIB, DIC), or market platforms for product promotion and livelihood support instead of only placement (e.g., exhibitions, online platforms, SHG/Cooperative marketing).

7. Process to register as a Training Provider (TP)/ Accreditation of TP.

1. The shortlisted bidders shall be accredited as per the CMKKY guidelines (https://www.kaushalkar.com/wp-content/uploads/2023/10/CMKKY_Guidline-Final_NEW-1.pdf).
2. Accreditation fees for the training provider will be INR. 50,000/-
3. Additionally, INR. 10,000/- will be charged per job role (If Applicable).

8. General Terms & Conditions:

i. Governing Law

The Empanelment Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Bengaluru shall have exclusive jurisdiction over all disputes arising under, pursuant to and/or in connection with the Empanelment Process.

ii. Confidentiality

1. Information relating to the examination, clarification, evaluation and recommendation for the Training providers shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional advisor advising KSDC in relation to, or matters arising out of, or concerning the Empanelment Process.
2. KSDC will treat all information, submitted as part of the Bid, in confidence and will require all those who have access to such material to treat the same in confidence. KSDC may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/or KSDC.

iii. Legal fees and Duties

The successful VTP/ Training provider shall be entirely responsible for stamp duties, license fees, and other such levies imposed.

iv. Change in Laws and Regulation

Unless otherwise specified in the Contract, if after the date of the Invitation for Bids, any law, regulation, ordinance, order or bylaw having the force of law is enacted, promulgated, abrogated, or changed that subsequently affects the Delivery Date and/or the Contract Price, then such Delivery Date and/or Contract Price shall be correspondingly increased or decreased, to the extent that the successful VTP/ Training provider has thereby been affected in the performance of any of its obligations under the Contract.

v. Force Majeure

The successful VTP/ training provider shall not be liable for forfeiture of its Performance Security, liquidated damages, or termination for default if and to the extent that its delays in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. Force Majeure shall not cover the price fluctuation of components.

For purposes of this clause, Force Majeure means an event or situation beyond the control of the successful VTP/ Training provider that is not foreseeable, is unavoidable, and its origin is not due to negligence or lack of care on the part of the successful Training provider. Such events may include, but not be limited to, acts of KSDC in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions, and freight embargoes.

If a Force Majeure situation arises, the successful VTP/ Training provider shall promptly notify KSDC in writing of such condition and the cause thereof. Unless otherwise directed by KSDC in writing, the successful VTP/ Training provider shall continue to perform its obligations under the Contract as far as it is reasonably practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

vi. Change orders and Contract Amendments

KSDC may at any time order the successful VTP/ Training provider to make changes within the general scope of the Contract, in any one or more of the following:

- i. The place of service delivery.
- ii. The related services to be provided by the successful Training provider.

If any such change causes an increase or decrease in the cost of, or the time required for, the successful Training providers performance of any provisions under the Contract, an equitable adjustment shall be made in the Contract Price or in the Delivery and Completion Schedule, or both, and the Contract shall accordingly be amended. Any claims by the successful VTP/ Training provider for adjustment under this Clause must be asserted within 45 days from the date of the successful Training provider's receipt of KSDC's change order.

vii. Termination

KSDC, at its discretion, can terminate the VTP/ Training Provider from imparting the skill training at any time in case any discrepancies found in imparting the skill trainings.

viii. Payment upon Termination

KSDC may consider making a payment for the part satisfactorily performed on the basis of Quantum Merit as assessed by it, if such part is of economic utility to the KSDC.

ix. Applicable laws

1. The Contract shall be interpreted in accordance with the laws prevalent in India
2. Compliance with all applicable laws: The VTP/ Training provider shall undertake to observe, adhere to, abide by, comply with and notify the Department about all laws in force or as are or as made applicable in future, pertaining to or applicable to them, their business, their employees or their obligations towards them and all purposes of this Tender and shall indemnify, keep indemnified, hold harmless, defend and protect the Department and its employees/ officers/staff/ personnel/representatives/ agents from any failure or omission on its part to do so and against all claims or demands of liability and all consequences that may occur or arise for any default or failure on its part to conform or comply with the above and all other statutory obligations arising there from.

Compliance in obtaining approvals/ permissions/ licenses: The VTP/ Training provider shall promptly and timely obtain all such consents, permissions, approvals etc., as may be necessary or required for any of the purposes of this project or for the conduct of their own business under any applicable Law, Government Regulation/Guidelines and shall keep the same valid and in force during the term of the project, and in the event of any failure or omission to do so, shall indemnify, keep indemnified, hold harmless, defend, protect and fully compensate the Department and its employees/ officers/ staff/ personnel/ representatives/agents from and against all claims or demands of liability and all consequences that may occur or arise for any default or failure on its part to conform or comply with the above and all other statutory obligations arising there from and the Department will give notice of any such claim or demand of liability within reasonable time to the Training provider.

All legal disputes are subject to the jurisdiction of Civil Courts Bangalore only.

x. General Terms of Proposal Submission

1. Each VTP/ Training provider must submit a single proposal.
2. Sub-contracting, sub-letting, franchisee arrangement of any kind for the conduct of training under this EOI is NOT allowed for any Organization/promoters of organization
3. KSDC does not guarantee target allocation to vocational training providers applying through this EOI.
4. The applicant organization once selected will be allocated targets and will be monitored for quality aspect of processes involved in training.
5. KSDC shall in no case be responsible or liable for the costs/expenses being incurred by the VTP/ Training provider while applying regardless of the conduct or the outcome of the process.
6. KSDC shall receive the proposal in accordance with the terms set forth in this EOI and other documents that may be provided by KSDC pursuant to this EOI as amended/clarified from time to time by KSDC.
7. Training providers shall not have a conflict of interest ("Conflict of Interest") that affects the EOI Process or any sanction of work that may follow. Any VTP/ Training provider found to have a Conflict of Interest is liable to be disqualified.
8. Any misrepresentation shall lead to disqualification of the Training provider.
9. KSDC will not return any proposal or any information provided along therewith.
10. KSDC reserves the right to verify all statements, information and documents submitted by the VTP/ Training provider in response to the EOI. Failure of KSDC to undertake such verification shall not relieve the VTP/ training provider of its obligations or liabilities hereunder nor will it affect any rights of KSDC there under.

xi. Failure to agree with the Terms & Conditions of the EOI

Failure of the VTP/ Training provider to agree with the Terms & Conditions of the EOI shall constitute sufficient grounds for the annulment of empanelment

xii. Right to accept and to reject any or all proposals or withdrawal of EOI

1. Notwithstanding anything contained in this EOI, KSDC reserves the right to accept or reject any proposal and to annul the empanelment process and reject all proposals at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof.
2. In case it is found during the evaluation of proposals or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the pre-qualification conditions have not been met by the VTP/ Training provider or that the VTP/ Training provider has made material misrepresentation or has given any materially incorrect or false information, the VTP/ Training provider shall be disqualified forthwith and the agreement, if signed, shall be liable to be terminated by a communication in writing by KSDC to the VTP/ Training provider, without KSDC being liable in any manner whatsoever to the VTP/ Training provider.

9. Other Tenets

- The VTPs/Training Providers accredited under KSDC, as well as Company/Partnership/NGO/SHG/Society/Trust/Vocational Training Provider and institutions with prior experience in Traditional/Regional crafts, shall be qualified to apply under this EOI.
- The selection of applicants to impart Traditional/Regional Job Roles skill training shall be based on, but not limited to, their infrastructure, training capacity, past performance in artisan or community training, geographical reach in Traditional/Regional skill clusters, and ability to provide sustainable livelihood linkages for artisans.
- Any documents submitted shall be verified by officials of KSDC to ensure correctness, and in case of discrepancies, the applicant may be rejected from receiving work orders.
- Training Providers/Institutions with higher capacity in terms of infrastructure, quality of training, community engagement, and proven experience in craft-based or self-employment-oriented skilling shall be preferred.
- The final number of TPs/Institutions selected and the training targets allocated for endangered Traditional/Regional job roles shall remain at the discretion of KSDC.
- KSDC reserves the right to amend any or all conditions of this EOI before the last date of submission or to revise the schedule at any time without assigning reasons.
- Shortlisted Training Providers/Institutions may be invited for a presentation before the technical evaluation committee.
- Implementation, monitoring, and reporting shall be governed as per the CMKKY Guidelines. The payment terms and pay-out mechanisms shall be governed as per the Special Project SOP, subsequent orders issued by the Government of Karnataka, and the Common Cost Norms Notification of the Ministry of Skill Development and Entrepreneurship (MSDE), Government of India. 10. Process to Apply for Imparting Traditional/Regional Job Roles Skill Training

- a. Eligible Training Providers, Artisan Institutions, SHGs, NGOs, Cooperative Societies, and Accredited VTPs interested in imparting **Traditional/Regional Job Roles (identified by the DSDO)** skill training shall apply online through <https://kppp.karnataka.gov.in/> under the CMKKY scheme.
- b. The applicants must specify the proposed job roles aligned with NSQF, along with details of infrastructure, trainer profiles, and training centers.
- c. Applicants are required to submit supporting documents such as registration certificates, past experience in conducting traditional/regional skill training or livelihood promotion, and details of clusters relevant to the identified endangered job roles.
- d. The proposals submitted will be scrutinized by KSDC based on eligibility, evaluation criteria, and relevance to **endangered Traditional/Regional Job Roles** training.
- e. Shortlisted applicants may be called for a presentation before the decision-making authority.
- f. The final selection and allocation of training targets shall be at the discretion of KSDC, as per government orders.

11. Clarifications

1. Applicants seeking any clarification on this Expression of Interest (EoI) may notify KSDC in writing through letter and/or e-mail at eoi_rfp@kaushalkar.com.
2. The KSDC shall endeavour to respond to such queries within the stipulated period through official communication (letter/e-mail). However, KSDC reserves the right, at its sole discretion, not to respond to any question(s) or provide any clarification(s). Nothing in this clause shall be construed as compelling or requiring KSDC to respond to every query.
3. KSDC may, on its own initiative, if deemed necessary, issue interpretations, amendments or clarifications to all applicants. Such clarifications shall be treated as an integral part of the EoI.
4. Any verbal communication, clarification, or information provided by KSDC officials, employees, or representatives shall not be considered binding unless formally issued in writing by KSDC.

12. Amendments

- a. At any time prior to the deadline for submission of Proposals, KSDC may, for any reason, whether at its own initiative or in response to clarifications requested by a training provider, modify the EOI by the issuance of Addenda.
- b. Any Addendum thus issued will be uploaded on the website. KSDC will post the addendum/replies to the queries on the KSDC website without identifying the source of queries.
- c. In order to afford the training providers a reasonable time for taking an addendum into account, or for any other reason, KSDC may, at its own discretion, extend the timelines mentioned having due regard for the time required by the training providers to address such amendment.

13. Payment structure:

1. All fund disbursements to training partners shall follow the mechanism and timelines prescribed under the Ministry of Skill Development & Entrepreneurship (MSDE) Common Cost Norms.
2. Payments to Training Providers shall be released in three tranches as follows:

Tranche	Proportion of Project Cost	Payment Release Condition
Tranche 1	40%	On completion of 25% of the prescribed training hours
Tranche 2	50%	Upon successful completion of training, assessment and certification of the trainees.
Tranche 3	10%	On achievement of market linkages activities

Verification & Documentation

- i. The first tranche of 40 percent of the project cost will be released on completion of 25 percent of the prescribed training hours, duly verified by the competent authority/DSC.

- ii. The second tranche of 50 percent will be released upon successful completion of the entire training, assessment, and certification of trainees by the approved Assessment and Certification Body, together with submission of the training completion report and certification results.
- iii. The final tranche of 10 percent will be released after the training partners demonstrate post-training outcomes such as exhibitions, sales support, linkages with State Corporations, or e-commerce/export/brand tie-ups, supported by MoUs, photographs, invoices, or sales records.
- iv. Reports from the District Skill Development Officers (DSDOs) confirming completion of training and certification milestones shall also serve as the basis for certifying, after verification of documentary proof, the eligibility for release of all 3 tranches.

Note: Since this initiative is training-focused, no placement-linked payout will apply.

14. Eligible beneficiaries

The candidates who belong to beneficiary communities shall be eligible for skill training in endangered Traditional/Regional job roles under the CMKKY Guidelines.
