Notice Inviting Expression of Interest for selection of Captive Employers & Regular PIAs under DDU-GKY 2.0

Tripura Rural Livelihood Mission (TRLM) under RD Department, Govt. of Tripura invites EOI from eligible & competent Project Implementing Agencies (PIAs) having valid Permanent Registration Number (PRN) obtained from the Ministry of Rural Development (MoRD), Govt. of India for placement linked skill development training of rural poor youths in Tripura in the Financial Year 2026-28 under Deen Dayal Upadhyaya Grameen Kaushalya Yojana 2.0 (DDU-GKY 2.0).

Under DDU-GKY 2.0 scheme, agencies are encouraged to undertake training and placement of rural youths strictly in accordance with the DDU-GKY guidelines and SOP in the skill gap existing in different sectors. Preference will be given to proposals offering short term, demand driven courses having good placement opportunities preferably in the following areas like IT & IITES, Apparel, Logistic, Tourism & Hospitality, Electronics, Construction, Automotive, Beauty and Wellness, Food processing, Handicraft, Hydrocarbon, Green Jobs, Retail, Aerospace & Aviation, Agriculture, Rubber, etc. The agencies applying under this EOI should possess valid LOI with companies/industries for placement. **Out of total target, 20% of the candidates shall be trained under 'Captive Employment' category. So, Captive Employers with PRN having in-house manpower requirement are encouraged to apply under this EOI as Captive Employer category.**

All training programmes under this EOI shall commence by 31st October 2026 and be completed on or before 31st December 2027. Initiation of placement / self-employment / gig employment of trained candidates shall be ensured on or before 31st March 2028. The State Project Approval Committee (SPAC) reserves the right to shortlist or reject any applicant and its decision regarding target allocation shall be final and binding on all applicants. Applicant PIAs should read and understand the DDU-GKY 2.0 guidelines and SOP before applying.
